The ultimate goal of the project is to ensure that at least 70% of small-scale farming women, men, and youth across the country are served by sustainable, powerful e-extension platforms. This will enable them to adopt planetpositive farming practices to earn a decent income and provide a better life for their families.

# Stakeholder Engagement on Data Protection and Privacy Act, 2019

s part of our commitment to data privacy and protection, WOUGNET in collaboration with APC members like Pollicy, conducted one-onone visits with key stakeholders. These visits aimed to disseminate research findings on the compliance of the Data Protection and Privacy Act 2019 with the AU Data Framework 2022. Stakeholders visited included; Ministry of ICT & National Guidance, Ministry of Gender Labor and Social Development, Uganda National Council for Science and Technology and Uganda Bureau of Statistics.

We provided insights on the current data protection laws and policies, challenges faced by women in safeguarding their personal data, opportunities for strengthening data privacy rights for women and best practices for data protection and privacy.

During these visits, stakeholders expressed a growing concern to raise awareness about the importance of data protection and privacy regulations, and recognized the significance of aligning Uganda's data protection laws with the AU Data Protection Framework202. Conversations focused on the benefits of enhanced data security, cross-border data flows and regional data governance. The insights shared during these visits will inform our future advocacy efforts and contribute to a more inclusive and informed data protection landscape in Uganda.

## Uganda's Progress for Universal Periodic Review

e had an insightful engagement organized by the Centre for Health, Human Rights and Development (CEHURD) regarding Uganda's progress for the Universal Periodic Review. The event brought together



key stakeholders, experts and human rights advocates to discuss and assess Uganda's advancements in human rights, challenges faced and recommendations for the future.

Participants engaged in a comprehensive review of Uganda's progress in implementing the recommendations from the previous year UPR cycles. This included



discussions on advancements in Sexual and Reproductive Health and

Rights (SRHR), gender equality, access to justice, and the protection of marginalized groups like persons with disabilities.

The dialogue also highlighted persistent challenges and concerns such as access to quality health care, maternal mortality rates, gender-based violence, discrimination against marginalized groups, and limitations on Freedom of Expression.

Valuable recommendations were put forth by experts and advocates, emphasizing the need for strengthened legal frameworks, enhanced access to justice, improved healthcare services, and the promotion of women's rights.

# Expert Review Engagement of ICT Intellectual Property Guidelines

ntellectual Property (IP) rights play a crucial role in fostering innovation, protecting innovations, and promoting creativity within the rapidly evolving technological landscape. These rights serve as a framework to safeguard the interests of creators. Innovators and inventors while also



encouraging the growth of the ICT sector.

In this regard, we participated in an expert review engagement of the ICT Intellectual Property Guidelines. This engagement, organized by the Ministry of ICT & National Guidance, brought together different Civil Society Organizations, legal practitioners and stakeholders to enhance the framework governing intellectual property rights within the ICT sector.

The expert review engagement aimed to assess the existing ICT Intellectual Property Guidelines, identify areas of improvement, propose recommendations to align the guidelines with international best practices and create a conducive environment for collaboration between stakeholders, including government, private sector, academia and innovators.

Following group discussions and reviews, various recommendations were suggested including capacity-building initiatives, training programs and awareness campaigns to educate different CSOs and innovators on IP rights and obligations.

This engagement allowed us to contribute insights and recommendations towards shaping innovation and ICT intellectual property. Our involvement in this engagement underscores our strategic objective to promote innovation and technological advancements.
